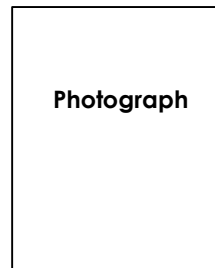

The completed, signed and dated registration form (Form) and these terms (including any incorporated terms) from a legally binding contract (Agreement) between the person named and the form (you) and the Guam Football Association. The Agreement sets out the terms on which you apply for and participate in, the course as nominated on the Form (Course.)

1. If you want to participate in the Course you must:
  - a. Complete all areas on and sign and date the Application Form;
  - b. Pay GFA the fees required, if any;
  - c. Send the Application to GFA to be received no later than the set deadline
2. GFA will not process any Application that does not comply with clause 1 or which is incorrect, incomplete, unclear or damaged.
3. If you are selected as a participant, GFA will notify you in writing using the nomination details on your Form.
4. Cancellations will be accepted by GFA only in exceptional circumstances depending on the proximity of the course dates.
5. You must comply with GFA By-Laws (copy of which is available upon request).
6. You agree to submit exclusively to the jurisdiction of the Advisory Board and not to attempt to resolve any dispute or grievance the subject matter of the GFA By-Laws in a court of law.
7. GFA may de-register you at any time by written notice, including if these Terms or its incorporated documents are not complied with.
8. GFA's liability to you is limited (at GFA's election) to GFA repaying any amounts paid by you under this Agreement or supplying or resupplying any Course services to which you are entitled in accordance with the forms of this Agreement.
9. You understand that there are inherent risks associated with participation in the Course, which may result in personal injury (even of a serious nature) to participants and that you fully accept and agree to bear those risks.
10. You agree not to bring any claim or proceeding against GFA for any damages, loss, injury or liability you may suffer in participating in, or being excluded from or failing the course. Except for liability that by law cannot be excluded, GFA excludes all liability to you in tort (including negligence), contract or bailment for acts or omission of GFA employees, agents and contractors.
